Judith is Senior Lecturer in Global Health at the School of Population Health, University of Auckland. Judith completed her Master of Public Health 1997 (Otago University) and PhD (University of Auckland) in 2002. Since this time she has been an active contributor to research in the field of health risk perceptions, tobacco control, media and global health. Judith is both lead and co-investigator on numerous international and national research projects funded by HRC, Bloomberg Initiative, World University Network, Ministry of Health and an active collaborator research and capacity building initiatives on in partnership with WHO and Secretariat for the Pacific Communities. Since being appointed to senior lecturer in global health, Judith has developed networks in Asia Pacific region; Latin America and North America, where she has participated in country and regional forums for global health and tobacco control. The Global Health Group, led by Judith, been awarded a Vice Chancellor's Strategic Development Award (2009) and an International Research Team Development Award (2010) to enhance international global health collaboration. She is the coordinator of Andrews Family fellowship initiative between the School of Population Health and the Fiji School of Medicine. Her major research interests include assessment of the impact of trade on health outcomes (child health, NCDs), tobacco industry activity in the Pacific region, media interpretations and health behaviours.
